Discussion was held regarding the re-installment of the street light pole on Main Street which included the time and temperature sign, as well as the flagpole being installed.

Discussion was held regarding the roof on the Community Center appears to be leaking over the storage area in the mezzanine, Dan Gerber will contact contractors to inspect the situation and provide a resolution to the problem that appears will continue to be an issue until corrective action is taken.
