Discussion was held on the Lester Park shelter project, Kurtis Myrlie made motion to approve the additional expenses of \$5,656.25 over the bid estimate to PMC. Lance Boote seconded the motion with all members voting in favor.

Discussion was held regarding the schedule for Road Guys, Curtis Doorneweerd will contact them to cancel their services this year.

Discussion was held regarding past due sewer and water accounts, Lester Post Office is past due 60 days.

Discussion was made regarding Lyon County Law Enforcement agreement, Jeff Hoogeveen made a motion to approve the 2025-2026 police protection contract. Curtis Doorneweerd seconded the motion with all members voting in favor.

Lester Development Committee updated the council, currently have 7 lots sold and will have a purchase agreement by the end of the month for lot 8. Thank you to Bob Leuthold, Roger Knobloch and Jon Blomgren for hours volunteering to move dirt in the new development to allow water to flow off the SE corner to avoid standing water.

Discussion was held regarding the new school bus stop in the Meadowview development. Jeff Hoogeveen made motion to approve the concrete bid of \$14,900 from Deere Creek Concrete. Kurtis Myrlie seconded the motion with all members voting in favor.

Lester Visioning presented to the council that they will be completing a LCRF grant application for a sun shade canopy for the ball diamond. Jeff Hoogeveen made motion to approve \$5,000 from the city to assist with the funding of the project if selected. Erika Kellenberger seconded the motion with all members voting in favor.

Discussion was held regarding a new City Clerk has been hired, Todd Boote, will begin training the month of August.

Lester Days are scheduled for August 16, 17 and 18, 2024.

The next regular city council meeting will be Monday, September 9, 2024, at 6:30 PM at the Lester City Council Chambers.

Kurtis Myrlie made a motion to adjourn the meeting. Erika Kellenberger seconded the motion with all members voting in favor.
